- A lifetime of accomplishments in effective communications
- Ethics and professionalism in their field
- Community service that improves the quality of life for others and positively affects the community

Great Corporate Communicator nominees must have successfully provided a campaign or project during 2020-2022 that demonstrates outstanding communications resulting in a positive impact on our community. Corporate includes but is not limited to for profit or non-profit companies and governmental entities.
